BDC Standing Orders Reports

Standing Orders Report No. 1

SECTION 1

Standing Orders Committee recommends the following running order for Monday the 23 April 2018 and Tuesday the 24 April 2018.

The President of Mandate Trade Union, John O'Donnell, calls Conference to order at 10.00 am sharp on Monday 23 April 2018.

The President calls on the Chair of Standing Orders, Peter Rooke, to put standing orders report Number 1 [sections 1 and 2] and reports number 2 and 3 to Conference and recommends that the Final Agenda as circulated to Conference is adopted

3. The Chair of Standing Orders Committee recommends that Conference elects:

- 5 Tellers
- 5 Scrutineers
- Liam Berney ICTU to act as Returning Officer
- After which the President of Mandate Trade Union, John O'Donnell, addresses Conference

4. Following the President's formal address to Conference on Monday 23 April 2018, the President calls on the ICTU General Secretary, Patricia King, to address Conference and launch the Conference theme 'Organise, Organise, Organise'.

5. That following the ICTU General Secretary's address to Conference, a short video on Mandate's campaigns and disputes over the last 2 years will be shown to Conference.

6. That following the presentation of the short video, the President calls on the General Secretary, John Douglas, to address Conference and introduce and move the adoption of the Biennial Report.

7. That following the address of General Secretary, John Douglas to Conference, that Motion No 1 National Executive Council will be taken, following which conference will adjourn at 11 am for fifteen minutes.
8. That prior to entering the Conference hall on Monday 23 April 2018 at 11.15 am sharp, delegates will collect ballot papers for the election of the National Executive Council.
9. That no business will be conducted between 11.15 am and 11.30 am on Monday 23 April 2018 other than voting by delegates for the National Executive Council.
10. That the morning session of Conference on Monday 23 April 2018, from 11.30 am onwards until 12.15 pm will be in private session.
11. That the General Treasurer's report is taken at 11.30 am sharp on Monday 23 April 2018 followed by Alteration to rules 1 and 2.
12. That Motions 2 from Letterkenny Local Council, 3 from City Centre Local Council (Dublin North West Division), 4 from National Executive Council, 5 Tullamore Local Council will be taken between 12.15 pm and 12.45 pm
13. That prior to Conference adjourning for lunch at 12.45 pm on Monday 23 April the results of the National Executive Council elections are declared to Conference.
14. That Conference adjourns for lunch at 12.45 pm on Monday 23 April 2018 and reconvenes at 2pm sharp.
15. That prior to entering the Conference hall on Monday afternoon 23 April 2018 at 2 pm sharp – delegates will collect ballot papers for the elections of President and Vice President.
16. That no business will be conducted between 2 pm and 2.15 pm on Monday 23 April 2018 other than voting by delegates for President and Vice President.
17. That Mandate's National Co-ordinator for Training, Jonathan Hogan, gives an address and presentation to Conference at 2.15 pm sharp on Monday 23 April 2018.
